

TERMS OF USE

1. General

By accessing and using the angele.music website (hereinafter the **Website**), you agree to comply with and be bound by these terms of use (hereinafter the **Terms**) and all applicable laws and regulations. By connecting to the Website, including any sub-sites using its interface and functions, you acknowledge that you have read and fully understood these Terms. If you do not accept them, please do not access or use this Website.

Its content is published, posted online, and operated by the Belgian company GGL Records SRL, whose registered office is located at 367 chaussée d'Alsemberg, 1190 Brussels (Belgium) and registered with the Crossroads Bank for Enterprises (CBE) under number 1037.338.091 (hereinafter referred to as "**we**," "**us**," and "**our**").

These Terms constitute and express the entire agreement between you and GGL SRL in connection with your use of the Website. Any other oral or written agreement that may have existed previously is replaced by the provisions of these Terms.

Any dispute relating to the interpretation or execution of these Terms and Conditions shall be submitted to mediation in French in Brussels (Belgium) by an accredited mediator, with the exclusive jurisdiction of the French-speaking courts and tribunals of the judicial district of Brussels (Belgium).
